Join us on Friday, November 6, 2026, at Ohio Northern University in Ada, Ohio for "2026 OPA Innovation Summit: Midyear Reimagined", a dynamic event dedicated to advancing the future of pharmacy practice through collaboration, clinical education, and problem-solving. Catalyzing the Future of Pharmacy

What would it take to make pharmacy innovation actually work? This interactive morning CE session invites pharmacists, technicians, pharmacy leaders, managed care organizations, PBMs, and other stakeholders to answer that question together. Participants will hear brief perspectives from across the pharmacy landscape, then work in facilitated small groups around four themes: pharmacy practice, the pharmacy legislative and regulatory landscape, drug pricing and reimbursement, and patient and provider engagement. Each group will select a priority, develop practical goals, identify who needs to be involved, consider barriers to implementation, and share a brief summary with the full group. Attendees will leave with a clearer understanding of the challenges facing pharmacy and concrete ideas for advancing patient care, payment, engagement, and practice sustainability in Ohio.

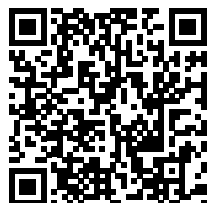


PARKING:
